

【Youth Water Forum】 2024 Application Rules

Please read and agree to the following before submitting your application to this call for proposals. By submitting your application, you are indicating your agreement to these terms and conditions.

(1) GENERAL CONDITIONS

Applicants shall apply at their own risk.

If applying as a group, please obtain all necessary consents from each group member.

(2) PORTRAIT RIGHTS, COPYRIGHTS, ETC. WHEN PRODUCING THE VIDEO

- If a person appears in the submitted video, please obtain the person's permission before submitting the video.
- If a person is in the submitted video, please obtain permission from that person to submit the video.
- Please do not film in areas where filming is prohibited.
- If you wish to use text, music, images, illustrations, or videos created by someone other than the members of the production group in your submitted video, please obtain the permission of the copyright holder of the relevant work before submitting it. However, when quoting text, images, illustrations, or videos, please be sure to clearly state the source in the video.

Programs and Newspapers

Citation: (program name, station name and date of broadcast, etc. must be indicated).

Images of companies, etc.

Citation: 00000 (company name), product name

For existing musical works, copyright procedures are required.

(3) COPYRIGHTS OF SUBMITTED VIDEOS

- All rights to the submitted videos will remain the property of the entrant.
- The entrant will be deemed to have given the Organizer permission to use the video free of charge (mainly for publicity purposes). The entrant shall be responsible for resolving any disputes that may arise regarding the submitted video.

(4) RESPONSIBLE PERSON

- The Organizer will not be held responsible for the content of the video.
- If the entrant is a minor, the person responsible must obtain the consent of a parent or guardian as indicated below before submitting the entry.
- If the entrant is a school or other group, a teacher must be the responsible person. If the applicant is an individual, the parent or guardian must be the responsible person.
- If applying as a group, all minors in the group must obtain the consent of their respective parents or guardians before submitting the application.
- The application will be deemed to have been submitted with the consent of all parents or guardians of the minors.

(5) UNACCEPTABLE VIDEOS

Entries that meet or may meet any of the following criteria cannot be accepted.

- Entries that infringe on the copyright, portrait rights or other rights of third parties.
- Entries that are offensive to public order and morals.
- Entries that have been created by someone other than the entrant.
- Entries that provide information, advertisements or solicitations for profit.
- Entries that defame or invade the privacy of individuals, companies or organizations.
- Those that impersonate other individuals, companies or organizations.
- Those that damage the reputation or credibility of this video call and damage trust in it.
- Entries that obstruct the proper operation of this call for videos.
- Entries that contain misinformation, inaccurate expressions or obvious exaggerations in the content of the work.
- Entries that the Organizer deems inappropriate.
- Any other entries similar to those listed above.

(6) UNACCEPTABLE VIDEOS

- The Organizer reserves the right to cancel the publication of the submitted video if it is found to be in breach of these terms and conditions, to be fraudulent or to infringe the rights of a third party after publication.
- The Organizer will not disclose the details of the decision as to whether or not the submitted video conforms to the application guidelines, etc.
- The costs associated with the production and submission of the video will be borne by the entrant. The Organizer will not lend out cameras, editing equipment, etc.
- The Organizer will not lend out cameras, editing equipment or other equipment.

- The Organizers reserve the right to change these terms and conditions in the event of changes in the content of the competition or if the Organizers deem it necessary to do so. In such cases, the Organizers will make the changes known to the public by posting them on the Organizers' website or by other means.

(7) DISCLAIMER

- The Organizers shall not be liable for any damage to the entrant or third parties caused by the filming and production of the submitted video, the submitted video or the information presented at the time of entry. The Organizers are also not liable for any damage incurred in relation to the internet services used for entry.
- The Organizers reserve the right to change, suspend, discontinue or terminate the contents of the Call for Videos without prior notice for unavoidable reasons. The Organizers shall not be liable for any damage incurred by the entrant or any third party in such cases.

(8) PERSONAL INFORMATION

The personal data provided at the time of application shall only be used to the extent necessary to achieve the purpose of this video application.
